### Larry Campagna Named “Texas Tax Legend” by the State Bar of Texas

**Houston, Texas – (June 24, 2019)** – Larry Campagna, shareholder in the Houston office of Chamberlain Hrdlicka, was recently named a “Texas Tax Legend” by the State Bar of Texas at its annual meeting in Austin.
